## EFFECTIVE 2016 CROP YEAR

### MEMBERSHIP

- Membership fee (*per year -- June 1 - May 31*)----- \$50.00

### FIELD INSPECTION FEES (*Field fees must accompany application*)

**PER ACRE**

- Corn & Sunflowers (*minimum fee per field<sup>1</sup> - \$170.00*)----- \$8.50
- Dry Edible Beans (*minimum fee per field<sup>1</sup> - \$65.00*)----- 3.25
- All Other Crops (Certified seed classes)
  - One Inspection (*minimum fee per field<sup>1</sup> - \$45.00*)----- \$2.25
  - Two Inspections (*minimum fee per field<sup>1</sup> - \$65.00*)----- 3.25
  - Three Inspections (*minimum fee per field<sup>1</sup> - \$85.00*)----- 4.25
- All Other Crops (Registered and Foundation seed class)
  - One Inspection (*minimum fee per field<sup>1</sup> - \$50.00*)----- \$2.50
  - Two Inspections (*minimum fee per field<sup>1</sup> - \$70.00*)----- 3.50
  - Three Inspections (*minimum fee per field<sup>1</sup> - \$90.00*)----- 4.50

**LATE APPLICATION<sup>2</sup> FEES** (*per field<sup>1</sup>*)----- \$20.00

**RE-INSPECTIONS** (*per field<sup>1</sup>*)----- \$50.00

**HOLD FEE** (*inspection fee for seed production field not producing seed*)----- \$10.00

**REFUNDS** – When fields are canceled, all of the fees, except \$10.00 per field will be refunded provided the request is made to the MCIA office prior to the time the field inspection is made. No refunds will be given for cancellations after the fields have been inspected.

<sup>1</sup> A field is defined as that area occupied by one variety of a crop, covered by one inspection report, and not divided by public roads, other crops, or barriers that materially increase the difficulty of inspection.

<sup>2</sup> The Association reserves the right to refuse inspection of fields included in late applications. If inspections can be arranged, the late application fee will be assessed.
