Remember this for Field Inspection Applications

It has been a hectic fast paced spring season and sometimes the paperwork is the last thing we want to do. As you move into the planting and growing season be sure that all your certification records are complete for you and your customers. Incomplete records can delay field inspection or create final certification issues later in the year.

Remember these items:

- 1. Check to make sure certification has been completed on all your seed lots.
- 2. Bulk certificates were properly issued to all your customers.
- 3. Save your proof of seed source for Foundation and Registered seed planted.
- 4. Resolve any pending issues about eligibility of seed source before inspection.

Keeping good records makes the certification process easier for everyone involved.

Field Inspection Application Deadlines

Please review these dates carefully in order to avoid late fees:

- June 7 Small grains, corn, sunflowers and other crops not listed below
- June 7 or 3 weeks after planting (whichever is first) Soybean post spray inspections
- June 7 Soybean bloom inspections
- Noxious weed seed free forage & mulch 4 weeks prior to each cutting
- July 15 Soybeans (pre-harvest inspection only)
- Year of Seeding Perennials and native grasses & forbs

Applications are mailed in May. Applications are also available online at www. mncia.org and may be submitted early if you do not wish to wait for the mailing.
