#### Soybeans - Seed Certification, IP Grain, QA & pre-harvest only

If you haven't submitted application(s) for soybean field inspection, they were due July 15. Please get them in as soon as possible.

Please be sure your small grain seed field has been inspected before you harvest. If you do not have a field inspection report, contact your field supervisor. Do not harvest unless you are sure it has been inspected.

# **Selling Cover Crop Seed**

Remember - all seed sold for planting purposes in Minnesota is subject to the provisions of the Minnesota Seed Law including requirements for cleaning, conditioning, sampling, testing, and labeling. Information on these requirements may be found at www.mda.state.mn.us/seed.

Some varieties are protected under PVP - Title V and must be sold as a class of certified seed. It is very important to maintain proper records and permissions when selling these varieties.
