Beginning July 1, 2015, the royalty rate for South Dakota State University (SDSU) varieties changed. A notice has been sent out and information is available on the MCIA website.

Wisconsin

As of July 1, 2015 the royalty rate increased to \$.30/bu for University of Wisconsin varieties. This includes Badger, BetaGeneTM, Esker and Ron oats. Growers who produced these and any Wisconsin varieties have been notified. A full list of Wisconsin varieties can be found on the MCIA website.
