# **Seed Laboratory Reminders**

A few reminders as we begin a new testing season:

- · The sample must be representative of your seed lot-the test results we obtain are a direct reflection of the sample that is provided.
- · Storing a sample prior to submitting-keep samples in a closed container in a clean, dry location away from excessive heat.
- Shipping samples—package properly to minimize damage and prevent spillage during transit.
- Include a completed Sampling Report and other relevant documentation for each sample submitted. Any missing information may cause delays in testing and final certification.

# **REMINDER: Have Your Fields Been Inspected?**

Be sure to contact your MCIA field supervisor if you are unsure whether a field has been inspected or if you have a field ready for harvest that has not been inspected. If the field supervisor is not available to speak with you, please leave them a detailed message that includes your name, phone number, the field in question, and the proposed date of harvest. Your call will be returned as soon as possible.


