Seed Lab Reminders

Remember to submit a completed Sampling Report with *every* sample submitted for testing—this includes preliminary germs and germ updates, retesting, etc.

Also, be sure to include any other documentation required to complete certification, such as Dome and Anthracnose results for field beans, Diaporthe and Pseudomonas results for OECD/EC soybeans, or molecular testing results when applicable for corn.

When Interagency Certification applies, include a completed and signed Certificate of Transfer for Seed Certification or proof of final certification (label or bulk cert). This will prevent delays in processing your samples.
